In order to receive the Form I-20, which is necessary to apply for an F-1 Student Visa to attend our institute, you must submit financial certification that you will have sufficient funds of at least \$4,345.00 (U.S. Dollars) to support yourself during the Summer Institute in English. NOTE: Applications received after May 3, 2019 will be accepted and processed but those who apply after May 3, 2019 may find it difficult to secure the necessary visa for entry to the U.S. Please refer to OIS website at www.ncsu.edu/ois/ for the most current immigration updates. *Students unable to arrive from overseas prior to June 26, 2019 will be unable to enroll and must return the I-20 (DS-2019) to Carolyn Howard at the address on the bottom of the Application Form.* It is required that you complete the following Certificate of Financial Responsibility (CFR) with attachments of any supporting documents to participate in the NC State University Summer Institute in English Program. Scholarship award letters alone are not acceptable; please provide supporting documentation.

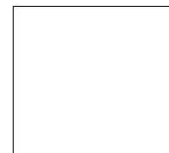
